

THE OFFICIAL RULES FOR THE BANCO POPULAR DE PUERTO RICO SWEEPSTAKES

1. NO PURCHASE NECESSARY TO ENTER OR WIN.

2. SWEEPSTAKES PERIOD. This sweepstakes (the “Sweepstakes”) begins on February 20, 2026, and ends on April 19, 2026 (the “Sweepstakes Period”).
