

THE OFFICIAL RULES FOR THE BANCO POPULAR DE PUERTO RICO SWEEPSTAKES
Getaway without leaving with Visa and Popular
(THE “RULES”)

1. NO PURCHASE NECESSARY TO ENTER OR WIN.

2. SWEEPSTAKES PERIOD. This sweepstakes (the “**Sweepstakes**”) begins on September 25, 2026, and ends on November 28, 2026 (the “**Sweepstakes Period**”).

3. PROMOTER. This Sweepstakes is sponsored by Banco Popular de Puerto Rico (“**Banco Popular**”), whose contact information is as follows:

4. ELIGIBILITY. Individuals who meet all the following criteria are eligible to participate in the Sweepstakes:

- a) Be a legal resident of Puerto Rico
- b) Be of legal age, be twenty-one (21) years old or older.
- c) Be a cardholder of at least one of the following credit cards: Visa PREMIA® Rewards, Visa Cash Rewards, Visa Novel, Visa Ideal, Visa Novel S, Visa Indigo, Popular / AAdvantage® Visa Signature, Popular / AAdvantage® Visa Signature Plus, Popular / AAdvantage® Visa Infinite, Visa Infinite y Visa Cobalt Infinite.
- d) Must not have a past due or charged-off account with Banco Popular or any of its affiliates, subsidiaries, or related companies.

Any employee of Popular Inc., and its subsidiaries and their respective advertising, promotions, and public relations agencies, are eligible to participate as long as they meet all the above criteria and have not participated in any of the stages of the Sweepstakes.

5. HOW TO PARTICIPATE. Participants may participate in the following ways:

- a) Cardholders: By calling toll free **1-877-222-2319** to enter the credit card number and offer code **6333** and using the eligible credit card during the Sweepstake’s Period. Participants will receive one (1) entry per \$1 in Purchases made during the Sweepstakes Period. Purchase credits posted during the Sweepstake’s Period will be excluded.

Mail-in entries must be postmarked by November 28, 2026, and received by Banco Popular by December 8, 2016. After the Sweepstake’s Period, entries will not be accepted. Entries received by mail without a purchase will be entered electronically.

6. SELECTION OF POTENTIAL WINNERS AND ALTERNATES.
