

## THE OFFICIAL RULES FOR THE BANCO POPULAR DE PUERTO RICO SWEEPSTAKES FILL QATAR WITH YOUR PASSION (THE "RULES")

- 1. NO PURCHASE NECESSARY TO ENTER OR WIN.
- **2. SWEEPSTAKES PERIOD**. This sweepstakes (the "Sweepstakes") begins on July 15, 2022, and ends on October 15, 2022 (the "Sweepstakes Period").

- **4. ELIGIBILITY.** Individuals who meet all of the following criteria are eligible to participate in the Sweepstakes:
  - (a) Be a legal resident of Puerto Rico
  - (b) Be of legal age (be twenty-one (21) years old or older)
