## WHAT DOES POPULAR, INC. DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all the information that can be shared. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect, and share depend on the product or service you have with us. This information can include:  • Social Security Number and Income  • Contact Information e.g., telephone number  • Account Balance and Transaction History  • Payment History and Credit History

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Popular, Inc. chooses to share; and whether you can limit this sharing.

Who we are	
Who is providing this notice?	Popular, Inc. and its affiliates (see definition below).

What we do		
How does Popular, Inc. protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
	Also, we limit the access only to employees who need it in order to provide products and services, or to comply with federal and local regulations.	
How does Popular, Inc. collect my personal information?	We collect your personal information, for example when you: <ul> <li>open an account or apply for a loan</li> <li>apply for financing or purchase securities from us</li> <li>apply for insurance</li> </ul>	
	We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.	
Why can't I limit all sharing?	Federal law gives you the right to limit only: • sharing for affiliates' everyday business purposes — information about your creditworthiness • affiliates from using your information to market to you • sharing for non-affiliates to market to you	
	State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.	
What happens when I limit sharing for an account I hold jointly with someone else?	Your choice(s) will apply to everyone on your account — unless you tell us otherwise.	

### **Definitions**

#### **Affiliates**

Companies related by common ownership or control. They can be financial and non-financial companies.

• Popular, Inc. Affiliates include Banco Popular de Puerto Rico, Popular Bank, Popular Auto, Popular Securities, Popular Insurance, eloan, Inc., Popular Risk Services and Popular Insurance Agency USA, Inc.

#### Non-affiliates

Companies not related by common ownership or control. They can be financial and non-financial companies.

• Popular, Inc. does not share with non-affiliates. As a result, they cannot market to you.

#### Joint marketing

A formal agreement between non-affiliated financial companies that together market financial products or services to you.

• Our joint marketing partners include Direct marketing, telemarketing, and insurance companies.

## State laws

You may have other privacy protections under applicable state laws. To the extent these state laws apply, we will comply with them when we share information about you.

California Residents – Your state law requires financial institutions to obtain your consent prior to sharing information about you with non-affiliated parties. We will limit sharing among our companies to the extent required by California Law.

Vermont Residents – We do not share information we collect about you with non-affiliated third parties, except as permitted by Vermont law, such as to process your transactions or maintain your account with your consent. In addition, we will not share information about your creditworthiness with our affiliates, except with your authorization, but we may share information about our transactions or experience with you with our affiliates without your consent.

Nevada Residents – Pursuant to Nevada law, if you prefer not to receive marketing calls from us, you may be placed on our internal Do Not Call list by calling 1.844.294.2576.

## Other applicable laws on the right to Privacy of information:

The following laws are intended to guarantee the rights of people with respect to the collection and use of their personal data.

BVI Data Protection Act, 2021 (DPA) – establishes a data protection framework that provides for various principles such as notice and choice, disclosure, security, and retention, and grants data subjects specific rights in relation to their personal data. General Data Protection Regulation (GDPR) – it is a legal framework that establishes guidelines for obtaining and processing the personal data of natural persons who are residents of the European Union (EU). The law directly impacts the storage, processing, access, transfer, and disclosure of personal data that we obtain about residents of the EU. Please refer to the **Privacy Rights Notice**.

California Consumer Privacy Act, as amended (CCPA) – the law was created to protect the privacy rights of information for consumers who are California residents. The law requires providing more information to consumers about what is being done with their personal information and giving them more control over how their information is shared.
